In 2008, she received the Order of Knight of the Legion of Honour (Chevalier de la Légion d'Honneur) from the president of the French Republic for her outstanding work on international human rights.

The Coalition Against Trafficking in Women International (CATW) strongly supports the candidacy of Ms. Wassyla Tamzali to the position as Special Rapporteur on Violence Against Women, Its Causes and Consequences.

Founded in 1988, CATW holds Consultative II status with the ECOSOC, and is a non-governmental organization that promotes women's human rights by working internationally to combat sexual exploitation in all its forms. CATW and its affiliated organizations monitor and function as clearinghouses for information and documentation on violations of women's human
