# Beijing +15 Overview and Regional Activities

#### The United Nations Fourth World Conference on Women

In September 1995, over 45,000 people converged on Beijing, China for the UN Fourth World Conference on Women¹ and the parallel NGO forum where women's rights advocates and government allies created what still stands as one of the most comprehensive and progressive UN documents to address the realities of women's lives. The resulting Beijing Declaration and Platform for Action identified twelve critical areas of concern (Women and poverty, Education and training of women, Women and health, Violence against women, Women and armed conflict, Women and the economy, Women in power and decision-making, Institutional mechanisms for the advancement of women, Human rights of women, Women and the media, Women and the environment, and The girl-child) and listed objectives and recommended actions to improve women's access to rights in these areas. Although the Platform for Action is not a legally binding document, it serves as a policy guide for governments, institutions, private businesses, and UN agencies, and establishes standards by which to judge policies and programs already in place. By adopting the Platform for Action, governments strongly committed themselves to addressing obstacles to the advancement and empowerment of women.

Since Beijing, a number of significant UN and government steps have been taken toward securing women's rights, including Goal 3 for Gender Equality in the Millennium Development Goals, the adoption of UN Security Council Resolution (SCR) 1325 on Women, Peace & Security and SCR 1820 on Sexual Violence in Conflict, and more and better national laws to address violence against women. Activism by women's rights organizations and women human rights defenders at the local, national, regional, and international levels has been a primary catalyst for many of these positive developments in women's rights over the past few decades.

As the former UN Secretary-General Boutros Boutros-Ghali noted in his statement on the concluding day of the Fourth World Conference on Women:

"The commitments made in Beijing are not only the result of diplomatic negotiation. Behind them lies the strong and organized power of the women's movement. The entire continuum of global conferences and summits has been shaped by the growing influence, passion and intellectual conviction of the women's movement." (1996: 1)<sup>2</sup>

Despite this progress, implementation of these victories remains challenging. Civil society must continue to fulfill its watchdog role and demand that governments implement the commitments made in the *Platform for Action*, especially in the face of new and emerging challenges, such as the global financial crisis. # What's happening for Beijing +15?

The 23<sup>rd</sup> Special Session of the General Assembly took place in 2000 to mark the 5<sup>th</sup> anniversary of the Fourth World Conference on Women (Beijing +5). At this session, governments adopted a political declaration and outcome document entitled "Further Actions and Initiatives to Implement the Beijing Declaration and Platform for Action." Again during a regular session of the Commission on the Status of Women in 2005 (49<sup>th</sup> Session),

the Beijing Declaration and Platform for Action and the outcome of the twenty-third special session of the General Assembly were reviewed and appraised at a high-level plenary meeting open to all UN Member States and Observers (Beijing +10).<sup>4</sup>

With 2010 quickly approaching, women's organizations around the world are talking about activities for the 15<sup>th</sup> Anniversary of the Beijing Conference. There will not be a separate General Assembly - Special Session convened by the United Nations; however, the theme for the 54<sup>th</sup> session of the Commission on the Status of Women will be "Review and appraisal of the implementation of the Beijing Declaration and Platform of Action and the outcome of the 23rd special session of the General Assembly." In preparation for this review, the UN regional commissions are working with the UN Division for the Advancement of Women (DAW) to distribute and collect questionnaires from governments about their laws, policies and practices related to gender.

The regional commissions as well as women's organizations, coalitions, and networks are planning regional activities over the coming months to discuss achievements and setbacks regarding the twelve critical areas of concern as outlined in the Platform. In many of these meetings and conferences, an emphasis will also be placed on examining how the global financial crisis will impact achievements towards improving women's rights.
